Government Decision of Government of Maharashtra, Department of Higher and Technical Education, Mumbai. Misc-2018/C.R.56/18/UNI-1 dt. 08th March, 2019 as well as Government of Maharashtra's circular Misc-2018/CR.58/18/UNI-1, dt. Issue c in the circular issued on May 10, 2019. 61 (V) and (VT) provides for selection committee for the selection and appointment of Principal/Teachers for minority status colleges like other colleges.

However, as per Article 30 (1) of the Constitution of India, all the minority classes have a fundamental right to establish and administer educational institutions of their choice. The said Article of Indian Constitution Hon. Supreme Court as well as Hon. The High Courts in their various judgments have time and again analyzed and held that interference with the right of minority bodies to govern is violative of Article 30(1) of the Constitution of India. Hon. Supreme Court as well as Hon. The High Courts in the have clarified that the selection and appointment of teachers is a part of administration, and if the minority institutions have followed the prescribed procedure, the state government or the university cannot interfere in the selection and appointment of teachers. Hon. In the petition of Forum of Minority Institutions and Blocked State of Tamil Nadu filed in Madras High Court Hon. High Court dt. The University Grants Commission vide order dated 05/01/2011 has ruled that the regulations reading the composition of selection committee are not applicable to minority institutions.

Through this circular, all the minority colleges/institutions in Savitribai Phule Pune University are informed as per the order received that the National Commission for Minorities Hon'ble Supreme Court as well as Hon. Appropriate action should be taken as per the directions given by the High Court from time to time.




